## Introduction To DPS 8 Table Editor

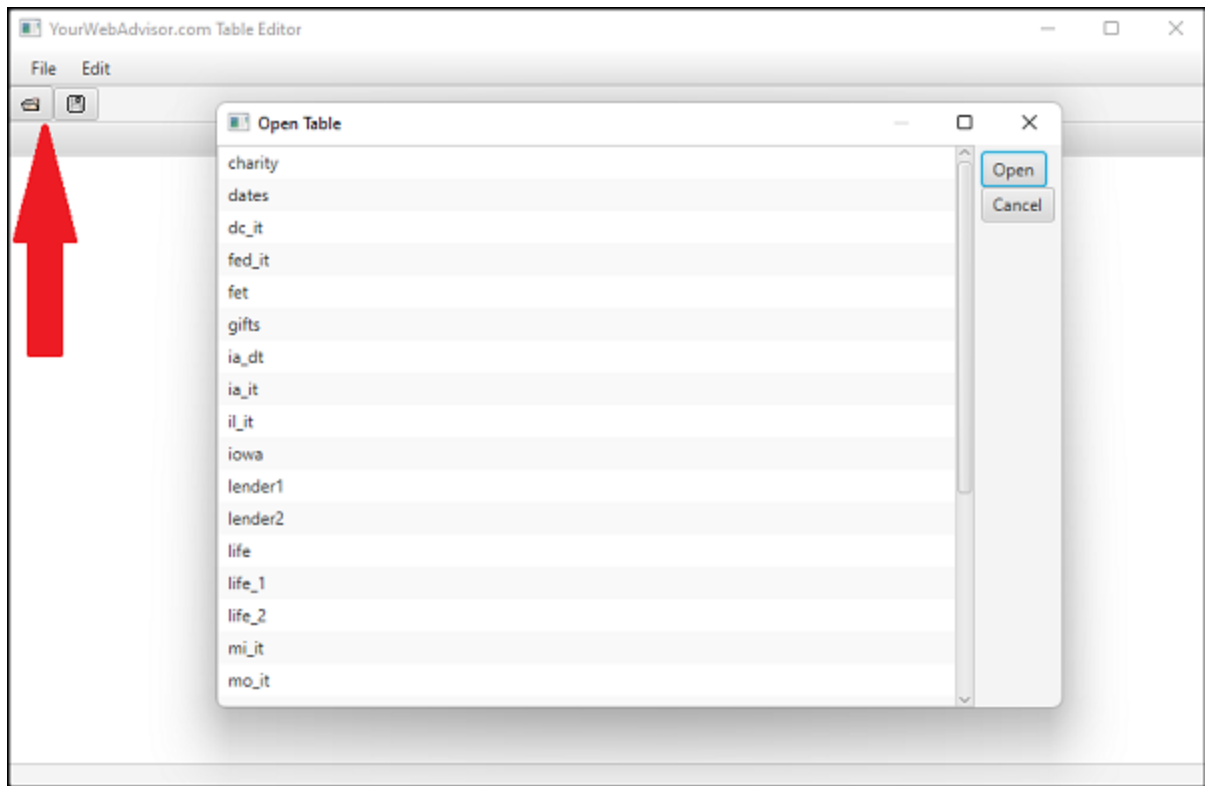
- DPS 8 Table editor creates the tables used by DPS 8 to establish various variables, such as:
  - names, which are dependent upon the state law
  - pronouns, which are dependent on the gender of the person referred to
  - numbers which are used by calculations in documents such as the federal estate tax return
  - system variables such as Preparer's Name and Address

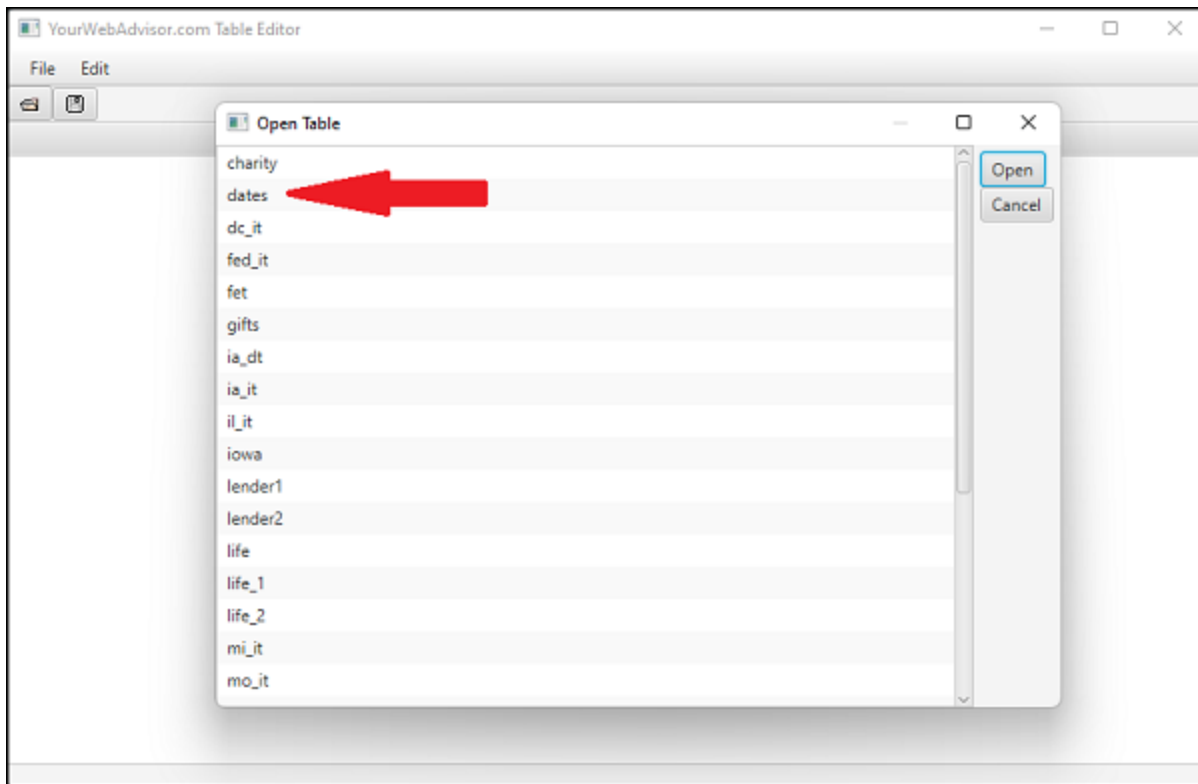

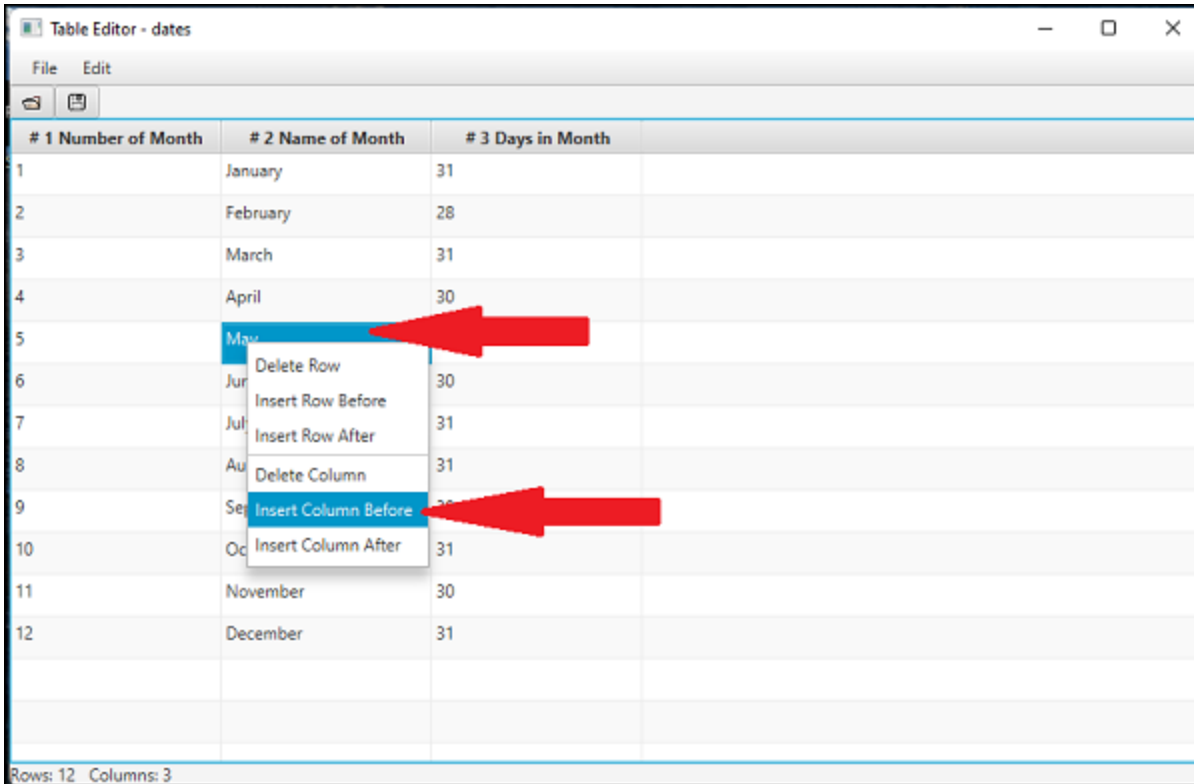

- You can (i) Insert a Row above or below the Row of the Cell selected or (ii) delete the Row of the Cell selected by right clicking on a cell



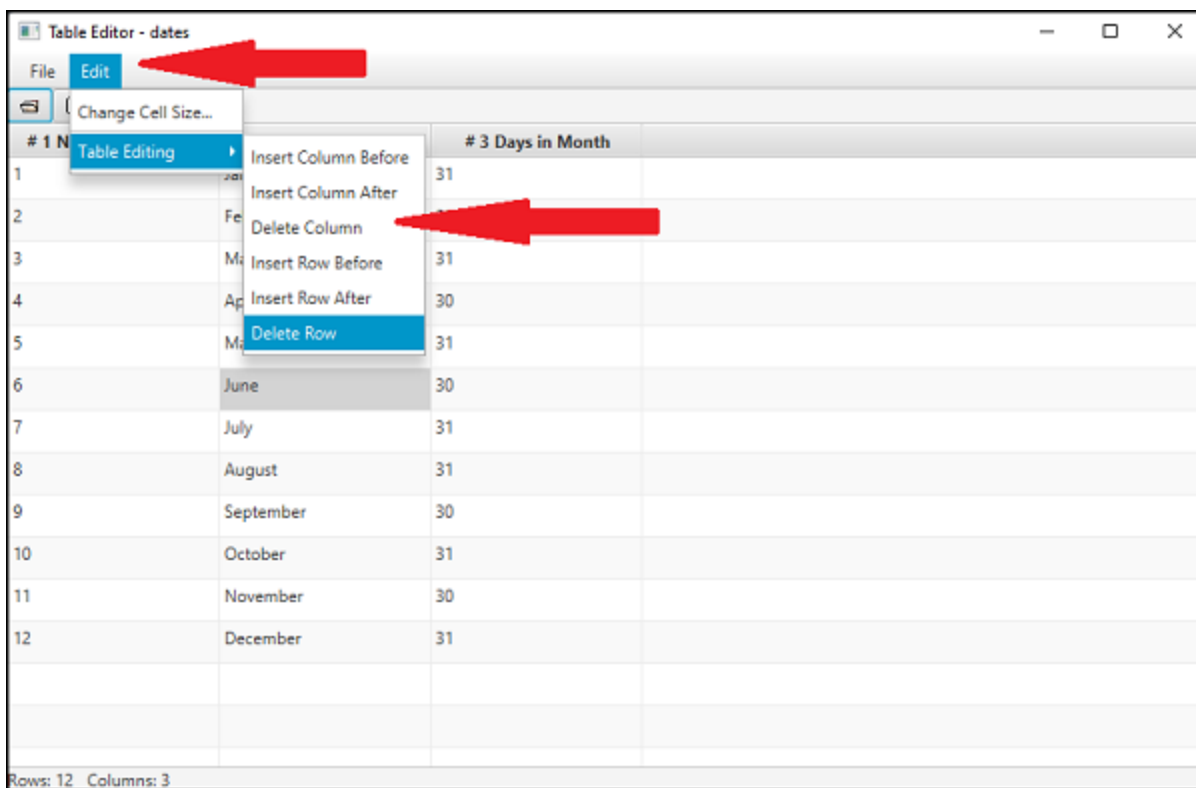

    - The size of a Cell can also be changed by dragging the vertical or horizontal borders of that cell
  - Under Table Editing
    - A Column can be Added Before or After the selected Cell
    - The Column of the selected Cell can be Deleted
    - A Row can be Added Above or Below the selected Cell
    - The Row of the selected Cell can be Deleted
